Some instructors will find one or two levels sufficient, whereas others will want to include all three. Both majors in botany and nonmajors who may initially be disinterested in the subject matter of a required course frequently become engrossed if the material is related repeatedly to their popular interests. This is reflected, as intimated above, in the considerable amount of ecology and ethnobotany included with traditional botany throughout the book. Organization of the Text A relatively conventional sequence of botanical subjects is followed. Chapters 1 and 2 cover introductory and background information; Chapters 3 through 11 deal with structure and function; Chapters 12 and 13 introduce meiosis, genetics, and molecular biology. Chapter 14 discusses plant propagation and biotechnology; Chapter 15 introduces evolution; Chapter 16 deals with classification; Chapters 17 through 23 stress, in phylogenetic sequence, the diversity of organisms traditionally regarded as plants; and Chapter 24 deals with ethnobotanical aspects and other information of general interest pertaining to 16 major plant families or groups of families. 25 and 26 present an overview of the vast topic of ecology, although ecological topics and applied botany are included in the preceding chapters as well.
