This book provides the first cross-regional study of an increasingly important form of politics: coalitional presidentialism. Modern democracy is organized as a representative democracy in which

those representing the people are elected to office. Political parties play a crucial role in this. They select the candidates, form or oppose governments, and organize the work of the representatives in parliament. This model of democracy is however being criticized. Parties are hardly trusted and voters have become volatile. How, then, do elected representatives of the people see and fulfil their role? To study this a survey was organized among the members of statewide and sub-state parliaments in fifteen countries. Members of seventy-three parliamentary assemblies were asked how they perceive their representative role, what they do to keep in touch with voters, how they behave and vote in parliament and how they will try to get re-elected. One of the ways in which candidates and elected members of parliament might react to the changing conditions in which they have to represent the people is by stressing more personal characteristics as opposed to the party label and party ideology. Representation might then become more a matter of personal choice. The results of the survey presented in this book do however confirm quite strongly that representation is very much shaped by the political institutions in which it is performed. Representation differs between countries, between different electoral systems, between statewide and regional parliaments, and depends strongly on the party to which a member of parliament belongs. Representation depends not as much on

who the representatives are, as on where they are.

Mobilization and Conflict in Multiethnic States - Manuel Vogt 2019

Why are some multiethnic countries more prone to civil violence than others? This book examines the occurrence and forms of conflict in multiethnic states. It presents a theory that explains not only why ethnic groups rebel but also how they rebel. It shows that in extremely unequal societies, conflict typically occurs in non-violent forms because marginalized groups lack both the resources and the opportunities for violent revolt. In contrast, in more equal, but segmented multiethnic societies, violent conflict is more likely. The book traces the origins of these different types of multiethnic states to distinct experiences of colonial rule. Settler colonialism produced persistent stratification and far-reaching cultural and economic integration of the conquered groups, as, for example, in Guatemala, the United States, or Bolivia. By contrast, in decolonized states, such as Iraq, Pakistan, or Sri Lanka, in which

independence led to indigenous self-rule, the colonizers' "divide and rule" policies resulted in deeply segmented post-colonial societies. Combining statistical analyses with case studies based on original field research in four different countries in Sub-Saharan Africa and Latin America, Vogt analyzes why and how colonial legacies have led to peaceful or violent ethnic movements.

Challenges to Consensual Politics - Daniele Caramani 2005

The book analyses the transnational Alpine region where historical, social, and geo-economic specificities have led to a distinctive type of democracy and identity. Differentialist identities, multi-level consociational accommodation, and corporatist intermediation are typical features of this region's «consensual politics», and the process of European integration adds further to this complexity. An empirical analysis by a group of international experts focuses on the Alpine areas of Austria, France, Germany, Italy, Slovenia, and Switzerland in which parties like FPÖ, CSU, Lega Nord, and Schweizerische Volkspartei have recently become crucial actors.

The interconnection between international organizations (IOs) membership and democratization has become a topic of intense debate. However, the main focus of the literature so far has been on IOs created by democratic states and comprised mostly of democracies, for examples the European Union. In contrast to existing studies, this book focuses on another group of regional IOs, referred to as 'non-democratic IOs' which are organizations founded by autocracies.
