The study revealed that physics pre-service teachers failed to emphasize the fact that momentum is vector quantity. Also the fact that only 15% of the participants scored a full point for the caricature related to the conservation of momentum is an issue which

should seriously be considered.

In the projects, in total 201 organisations (industrial, commercial, and universities) from 12 European Union member states and 5 EFTA countries are represented. The DELTA programme pays much attention to the exchange of ideas and dissemination of information both between individual DELTA projects and between DELTA projects and

other initiatives in the EU. Meetings in which DELTA projects are involved are held several times a year as so-called 'concertation meetings', meetings where also non-DELTA projects participate are called 'concerted actions'.
