Gorman—affectionately known as “Dr Space Junk”—takes readers on a journey through the solar system and beyond, deploying space artifacts, historical explorations, and even the occasional cocktail recipe in search of the ways that we make space meaningful. Engaging and erudite, Gorman recounts her background as a (nonspace) archaeologist and how she became interested in space artifacts. She shows us her own piece of space junk: a fragment of the fuel tank insulation from Skylab, the NASA spacecraft that crash-landed in Western Australia in 1979. She explains that the conventional view of the space race as “the triumph of the white, male American astronaut” seems inadequate; what really interests her, she says, is how everyday people engage with space. To an archaeologist, objects from the past are significant because they remind us of what we might want to hold on to in the future.

The contributions in this volume bridge this gap by analyzing the river both as a natural and as a cultural phenomenon. Adopting an approach of cultural ecology, it addresses issues like ancient land use, administration and taxation, irrigation, and religious concepts.

**Landscape Ecology in Asian Cultures** - Sun-Kee Hong 2010-12-25

Cultural landscapes are a product of the interactions between humans and natural settings. They are landscapes and seascapes that are shaped by human history and land use. Socioeconomic processes especially, but also environmental changes and natural disturbances, are some

of the forces that make up landscape dynamics. To understand and manage such complex landscapes, interdisciplinary and transdisciplinary approaches are necessary, emphasizing the integration of natural and social sciences and considering multiple landscape functions. The spatial patterns of Asian landscapes are strongly related to human activities and their impacts. Anthropogenic patterns and processes have created numerous traditional cultural landscapes throughout the region, and understanding them requires indigenous

knowledge. Cultural landscape ecology from a uniquely Asian perspective is explored in this book, as are the management of landscapes and land-use policies. Human-dominated landscapes with long traditions, such as those described herein, provide useful information for all ecologists, not only in Asia, to better understand the human-environmental relationship and landscape sustainability.
