concepts of Jordan measure and the Riemann integral), before moving on to abstract measure and integration theory, including the standard convergence theorems, Fubini's theorem, and the Carathéodory extension theorem. Classical differentiation theorems, such as the Lebesgue and Rademacher differentiation theorems, are also covered, as are connections with probability theory. The material is intended to cover a quarter or semester's worth of material for a first graduate course in real analysis. There is an emphasis in the text on tying together the abstract and the concrete sides of the subject, using the latter to illustrate and motivate the former. been added to Chapter 7. There is more material than can be covered in a semester and instructors will need to make selections and perhaps use certain topics as honors or extra credit projects. To provide some help for students in analyzing proofs of theorems, there is an appendix on "Logic and Proofs" that discusses topics such as implications, negations, contrapositives, and different types of proofs. However, it is a more useful experience to learn how to construct proofs by first watching and then doing than by reading about techniques of proof. Results and proofs are given at a medium level of generality. For instance, continuous functions on closed, bounded intervals are studied in detail, but the proofs can be readily adapted to a more general situation. This approach is used to advantage in Chapter 11 where topological concepts are discussed. There are a large number of examples to illustrate the concepts, and extensive lists of exercises to challenge students and to aid them in

understanding the significance of the theorems. Chapter 1 has a brief summary of the notions and notations for sets and functions that will be used. A discussion of Mathematical Induction is given, since inductive proofs arise frequently. There is also a section on finite, countable and infinite sets. This chapter can be used to provide some practice in proofs, or covered quickly, or used as background material and returning later as necessary. Chapter 2 presents the properties of the real number system. The first two sections deal with Algebraic and Order properties, and the crucial Completeness Property is given in Section 2.3 as the Supremum Property. Its ramifications are discussed throughout the remainder of the chapter. In Chapter 3, a thorough treatment of sequences is given, along with the associated limit concepts. The material is of the greatest importance. Students find it rather natural although it takes time for them to become accustomed to the use of

epsilon. A brief introduction to Infinite Series is given in Section 3.7, with more advanced material presented in Chapter 9 Chapter 4 on limits of functions and Chapter 5 on continuous functions constitute the heart of the book. The discussion of limits and continuity relies heavily on the use of sequences, and the closely parallel approach of these chapters reinforces the understanding of these essential topics. The fundamental properties of continuous functions on intervals are discussed in Sections 5.3 and 5.4. The remainder of the chapter consists of applications of the Mean Value Theorem and may be explored as time

permits. In Chapter 7, the Riemann integral is defined in Section 7.1 as a limit of Riemann sums. This has the advantage that it is consistent with the students' first exposure to the integral in calculus, and since it is not dependent on order properties, it permits immediate generalization to complex- and vector-valued functions that students may encounter in later courses. It is also consistent with the generalized Riemann integral that is discussed in Chapter 10. Sections 7.2 and 7.3 develop properties of the integral and establish the Fundamental Theorem and many more.

Beginning with the construction of the number systems and set theory, the book discusses the basics of analysis (limits, series, continuity, differentiation, Riemann integration), through to power series, several variable calculus and Fourier analysis, and then finally the Lebesgue integral. These are almost entirely set in the concrete setting of the real line and Euclidean spaces, although there is some material on abstract metric and topological spaces. The book also has appendices on mathematical logic and the decimal system. The entire text (omitting some less central topics) can be taught in two quarters of 25–30 lectures each. The course material is deeply intertwined with the exercises, as it is intended that the student actively learn the material (and practice thinking and writing rigorously) by proving several of the key results in the theory.

This book is based on an honors course in advanced calculus that the authors gave in the 1960's. The foundational material, presented in the unstarred sections of Chapters 1 through 11, was normally covered, but different applications of this basic material were stressed from year to year, and the book therefore contains more material than was covered in any one year. It can accordingly be used (with omissions) as a text for a year's course in advanced calculus, or as a text for a three-semester introduction to analysis. The prerequisites are a good grounding in the calculus of one variable from a mathematically rigorous point of view, together with some acquaintance with linear algebra. The reader

should be familiar with limit and continuity type arguments and have a certain amount of mathematical sophistication. As possible introductory texts, we mention Differential and Integral Calculus by R Courant, Calculus by T Apostol, Calculus by M Spivak, and Pure Mathematics by G Hardy. The reader should also have some experience with partial derivatives. In overall plan the book divides roughly into a first half which develops the calculus (principally the differential calculus) in the setting of normed vector spaces, and a second half which deals with the calculus of differentiable manifolds.

Principles of Mathematical Analysis - Walter Rudin 1976

The third edition of this well known text continues to provide a solid foundation in mathematical analysis for undergraduate and first-year graduate students. The text begins with a discussion of the real number system as a complete ordered field. (Dedekind's construction is now treated in an appendix to Chapter I.) The topological background needed for the development of convergence, continuity, differentiation and integration is provided in Chapter 2. There is a new section on the gamma function, and many new and interesting exercises are included. This text is part of the Walter Rudin Student Series in Advanced Mathematics.
