More recent texts have emphasized connections with real analysis, which is important, but at the cost of exhibiting succinctly and clearly what is peculiar about complex analysis: the power series expansion, the uniqueness of analytic continuation, and the calculus of residues. The systematic elementary development of formal and convergent power series was standard fare in the German texts,

but only Cartan, in the more recent books, includes this material, which I think is quite essential, e. g. , for differential equations. I have written a short text, exhibiting these features, making it applicable to a wide variety of tastes. The book essentially decomposes into two parts.

Distributions - J.J. Duistermaat 2010-08-09

This textbook is an application-oriented introduction to the theory of distributions, a powerful tool used in mathematical analysis. The treatment emphasizes applications that relate distributions to linear partial differential equations and Fourier analysis problems found in mechanics, optics, quantum mechanics, quantum field theory, and signal analysis. Modular Forms, a Computational Approach -
